RESOLUTION 16-70

AUTHORIZING AWARDING OF CONTRACT FOR SPRING ACTIVATION AND FALL WINTERIZATION TO CERTAIN UNDERGROUND IRRIGATION SYSTEMS WITHIN THE TOWNSHIP OF UPPER DEERFIELD

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing spring activation and fall winterization to irrigation systems within the Township beginning March 1, 2016 to December 31, 2016 from Dutch Neck Landscaping, Rainbow Sprinklers, TBI Unlimited, and Wetlawn Automatic Sprinkler Systems; and
