

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION # 17-150

**AUTHORIZING INSTALLMENT TAX PAYMENTS REGARDING
BLOCK 1109, LOT 1.01 ON THE TAX MAP OF THE TOWNSHIP OF UPPER DEERFIELD**

WHEREAS, there are arrearages with respect to property taxes due and owing with respect to Block 1109, Lot 1.01 on the Tax Map of the Township of Upper Deerfield which property is owned by Estate of Joyce Baeder and commonly known as 130 Silver Lake Road within the Township of Upper Deerfield; and

WHEREAS, the owner has requested that tax arrearages together with the first and second quarter 2017 taxes be allowed pursuant to a payment plan; and

WHEREAS, redemption of arrearages is permissible pursuant to N.J.S.A. 4:5-65, et seq.; and

WHEREAS, the tax collector of the Township of Upper Deerfield has calculated arrearages together with interest and has recommended the allowance of the tax installment plan on behalf of the tax payer;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that Estate of Joyce Baeder of 130 Silver Lake Road, owner of property known as Block 1109, Lot 1.01 on the Tax Map of the Township of Upper Deerfield be and is hereby permitted to pay property tax arrearages which have accumulated in the amount of \$7,552.44 together with interest to June 30, 2018, of \$2,076.24 for a total amount due of \$9,628.68; and

BE IT FURTHER RESOLVED that the payment plan to liquidate the foregoing arrearages shall be made over a period of 12 months in the amount of \$802.39 per month commencing on July 30, 2017, and ending June 30, 2018; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the payment of tax arrearages pursuant to the foregoing installment payment plan shall be conditioned upon current taxes together with any additional accumulated interest being paid in a timely fashion.
