RESOLUTION 17-243

**AWARDING BID TO LIBERTY KENWORTH OF SOUTH JERSEY FOR
THE PURCHASE OF A UTILITY TRUCK WITH TANDEM ROLL-OFF CHASSIS,
SNOW PLOW WITH SPREADER AND SELF-CONTAINED DEBRIS COLLECTOR**

WHEREAS, the Township of Upper Deerfield authorized bids with respect to the purchase of a utility truck with tandem roll-off chassis, snow plow with spreader and debris collector; and

WHEREAS, bids were received on July 27, 2017 from Liberty Kenworth of South Jersey. - \$204,069.00 for the base bid, \$45,716.00 for Alternate #1 – Snow Plow & Spreader and \$55,195.00 for Alternate #2 – Self Contained Debris (Leaf) Collector for a total bid of \$304,980.00. No other bids were received; and

WHEREAS, Liberty Kenworth of South Jersey of Swedesboro, New Jersey, submitted the lowest total bid of \$204,069.00 for the base bid, \$45,716.00 for Alternate #1 and \$55,195.00 for Alternate #2 –for a total bid of \$304,980.00 as set forth in the bid specifications; and

WHEREAS, the Engineer has recommended that the base bid, Alternate #1 and Alternate #2 be awarded to Liberty Kenworth of South Jersey in the amount of \$304,980.00 as the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for the base bid Alternate #1 and Alternate #2to Liberty Kenworth of South Jersey as aforesaid; and

WHEREAS, the award of the aforesaid bid to Liberty Kenworth of South Jersey is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

WHEREAS, funds are available for the base bid contract and have been certified by the local finance officer; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of Liberty Kenworth of South Jersey be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract for the base bid Alternate #1 and Alternate #2 to purchase a utility truck with tandem roll-off chassis, snow plow with spreader and debris collector in the amount of \$304,980.00 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
