RESOLUTION 17-244

**AWARDING BID TO CATERINA SUPPLY, INC. FOR
MATERIALS FOR WATER MAIN PIPING, VALVES, FITTINGS AND HYDRANTS**

WHEREAS, the Township of Upper Deerfield authorized bids with respect to supplying materials for water main piping, valves, fittings and fire hydrants; and

WHEREAS, bids were received on August 29, 2017 from Caterina Supply Inc. - \$63,406.59 for the base bid and \$11,852.40 for Alternate #1 for a total bid of \$75,258.99, from Raritan Pipe and Supply Co. - \$70,300.79 for the base bid, and \$10,297.60 for Alternate #1 for a total bid of \$80,598.39 and from Water Works Supply Co. - \$73,107.41 for the base bid and \$13,300.84 for Alternate #1 for a total bid of \$86,408.25; and

WHEREAS, Caterina Supply Inc. of Williamstown, New Jersey, submitted the lowest total bid of \$63,406.59 for the base bid and \$11,852.40 for Alternate #1 for a total bid of \$75,258.99 as set forth in the bid specifications; and

WHEREAS, the Engineer has recommended that the base bid and Alternate #1 be awarded to Caterina Supply Inc. in the amount of \$63,406.59 as the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for the base bid and Alternate #1 to Caterina Supply Inc. as aforesaid; and

WHEREAS, the award of the aforesaid bid to Caterina Supply Inc. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

WHEREAS, funds are available for the base bid contract and have been certified by the local finance officer; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of Caterina Supply Inc. be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract for the base bid and Alternate #1 supplying materials for water main piping, valves, fittings and fire hydrants in the amount of \$75,258.99 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that bid bonds may be returned to unsuccessful bidders; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
