

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 17-40

**APPOINTING TOWNSHIP CONSTRUCTION CODE OFFICIALS
AND CERTIFYING SALARIES**

WHEREAS, the Township of Upper Deerfield and the City of Millville are entering into a shared service agreement whereby the Township of Upper Deerfield will be providing construction office services to the City of Millville; and

WHEREAS, the Township of Upper Deerfield will need to hire additional construction office officials to carry out the shared service agreement; and

WHEREAS, in the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the officials hired under this resolution will be terminated from the designated position and the salary associated with the positions listed will be pro-rated to the last day the shared service agreement is in effect.

NOW THEREFORE BE IT RESOLVED, that the following officials and employees are hereby appointed to serve the Township during 2017 for the sole purpose of filling the positions required to carry out the shared service agreement for construction office code review and inspections services with the City of Millville; and

BE IT FURTHER RESOLVED, that in the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the officials hired under this resolution will be terminated from the designated position and the salary associated with the positions listed will be pro-rated to the last day the shared service agreement is in effect; and

BE IT FURTHER RESOLVED, that the following individuals serve at the pleasure of the Township Committee for a term not to exceed December 31, 2017 or the last day the shared service agreement with Millville is in effect, whichever shall come first. In the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the Building Inspector and Electrical Inspector hired under this resolution will be terminated from the designated position and the salary associated with that position listed will be pro-rated to the last day the shared service agreement is in effect. The Township Committee wishes to certify for payroll purposes the specific salary amount within the ranges specified by Ordinance No. 749 for the persons holding said job positions:

Building Inspector	John "Jack" Palumbo	\$28,152.00/yr.
Electrical Inspector	Stacy Davis	\$24,480.00/yr.

BE IT FURTHER RESOLVED THAT, Ordinance No. 749 sets a salary range for various officials of the Township and certain municipal job positions of such term as is fixed by law and the Township Committee wishes to certify for payroll purposes the specific salary amount within the ranges specified for the persons holding said job positions as set forth herein are hereby certified as the 2017 salary or hourly wage rate. In the event the shared service agreement between the Township of Upper Deerfield and the City of Millville is cancelled by either party, the plumbing sub code official hired under this resolution will be terminated from the designated position of Plumbing Sub Code Official for Millville Shared Service and the salary associated with that position listed will be pro-rated to the last day the shared service agreement is in effect.

The Township Committee wishes to certify for payroll purposes the specific hourly rate within the ranges specified by Ordinance No. 749 for the persons holding said job positions:
