RESOLUTION 17-88

AWARDING PROPOSAL FOR HOME REHABILITATION - RAINES

WHEREAS, the Township of Upper Deerfield authorized the receipt of quotes for installation of a septic system of a home within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Revolving Loan Account; and

WHEREAS, the Township of Upper Deerfield requested proposals for the installation of a septic system for James & Cheryl Raines, 7 Weymouth Road from Gary Holman Contracting, Inc, Pierce Septic System, Inc., Watson & Sons, Septic Systems by Regalbuto and Rafine Excavating, LLC; and

WHEREAS, three proposals were received from: Rafine’s Excavating LLC. - \$12,666.10, Septic Systems by Regalbuto - \$12,500.00 and Watson & Sons - \$13,900.00 to install a septic system in compliance with specifications; and

WHEREAS, Septic Systems by Regalbuto was deemed to be the lowest responsible bidder with respect to the individuals property in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the Township of Upper Deerfield is desirous of accepting the aforesaid bid;

WHEREAS, funds are available and have been certified by the local finance officer; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the rehabilitation proposal for the property listed below within the Township of Upper Deerfield is accepted by the Township of Upper Deerfield and is hereby awarded to Septic Systems by Regalbuto in the amount of \$12,500.00 for James & Cheryl Raines, 7 Weymouth Road Bridgeton NJ, 08302 to be funded by Small Cities Revolving Loan Account; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into contract with Septic Systems by Regalbuto for rehabilitation of the above property and for the amount indicated according to the terms and specifications and in a form satisfactory to the Township Solicitor to the Township of Upper Deerfield.
