

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 18-101**

**AUTHORIZING INSTALLMENT TAX PAYMENTS REGARDING  
BLOCK 2602, LOT 22 ON THE TAX MAP OF THE TOWNSHIP OF UPPER DEERFIELD**

**WHEREAS**, there are arrearages with respect to property taxes due and owing with respect to Block 2602, Lot 22 on the Tax Map of the Township of Upper Deerfield which property is owned by Robert Dolson and commonly known as 229 Rosenhayn Avenue within the Township of Upper Deerfield; and

**WHEREAS**, the owner has requested that they be allowed to enter into an installment payment plan with respect to the payment of such tax arrearages; and

**WHEREAS**, redemption of arrearages is permissible pursuant to N.J.S.A. 54:5-65, et seq.; and

**WHEREAS**, the tax collector of the Township of Upper Deerfield has calculated arrearages together with interest through May 15, 2019, in the amount of \$6,067.91 and has recommended the allowance of the tax installment plan on behalf of the tax payer;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that Robert Dolson of 229 Rosenhayn Avenue, owner of property known as Block 2602, Lot 22 on the Tax Map of the Township of Upper Deerfield be and is hereby permitted to pay property tax arrearages which have accumulated in the amount of \$6,067.91 together with interest to May 31, 2019, of \$1,286.24; and

**BE IT FURTHER RESOLVED** that the payment plan to liquidate the foregoing arrearages shall be made over a period of 12 months in the amount of \$599.53 per month commencing on May 31, 2018, and ending May 31, 2019; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the payment of tax arrearages pursuant to the foregoing installment payment plan shall be conditioned upon current taxes together with any additional accumulated interest being paid in a timely fashion.
