**RESOLUTION 18-162**

**AWARDING CONTRACT FOR PROVIDING OCCASIONAL HAULING OF COMPACTORS AND DUMPSTERS FROM THE UPPER DEERFIELD TOWNSHIP CONVENIENCE CENTER TO CUMBERLAND COUNTY SOLID WASTE COMPLEX AND/OR GIORDANO VINELAND SCRAP AND METAL CO.**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing occasional hauling service from the convenience center to CC Solid Waste Complex and Giordano Vineland Scrap and Metal Co. for a term of one year beginning July 1, 2018 to June 30, 2019 from C&H Disposal, Red Oak Inc and RJM Services; and
