RESOLUTION 18-226

AUTHORIZING INTERLOCAL SERVICE AGREEMENT BETWEEN THE TOWNSHIP OF UPPER DEERFIELD AND TOWNSHIP OF STOW CREEK WITH RESPECT TO THE PROVISION OF CONSTRUCTION CODE SERVICES

WHEREAS, the Township of Upper Deerfield and the Township of Stow Creek both need to provide construction code services with respect to inspection of construction, clerical, and secretarial time related thereto; and

WHEREAS, the Township of Upper Deerfield and the Township of Stow Creek have established an interlocal service agreement which specifies the construction code services provided for a Construction Code Official, Building Subcode Official, Electrical Subcode Official, Plumbing Subcode Official, Fire Subcode Official and clerical and administrative services for a term beginning January 1, 2019 and ending December 31, 2022; and

WHEREAS, the Township of Upper Deerfield and the Township of Stow Creek are desirous of maintaining an interlocal service agreement pursuant to N.J.S.A. 40:8A-1, et seq., to jointly provide, administer and bear the cost of such services; and

WHEREAS, the Township Committee of the Township of Upper Deerfield finds that an agreement with the Township of Stow Creek to perform such services is in the interests of the residents of the Township of Upper Deerfield;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into an agreement for shared services with the Township of Stow Creek pursuant to N.J.S.A. 40:8A-1, et seq. for the provision of construction code services and building, electrical, plumbing and fire subcode services as well as administrative and clerical time related thereto pursuant to an agreement, the form of which shall be satisfactory to the Mayor, Administrator, and Solicitor of the Township of Upper Deerfield;
