**RESOLUTION 18-64**

**AUTHORIZING AGREEMENT WITH CUMBERLAND COUNTY SPCA  
& SOUTH JERSEY REGIONAL ANIMAL SHELTER**

**WHEREAS**, the Township of Upper Deerfield is desirous of providing services for sheltering of animals; and

**WHEREAS**, the Township of Upper Deerfield utilized a fair and open process to acquire the services for the sheltering of animals in accordance with the provisions of N.J.S.A. 19:44A-20.5; and

**WHEREAS**, the Township of Upper Deerfield requested proposals for the sheltering of animals for the period of March 1, 2018 through December 31, 2018 from the Cumberland County SPCA, Gloucester County Animal Shelter and the Atlantic County Animal Shelter; and

**WHEREAS**, the Cumberland County SPCA submitted a proposal in the amount of \$24,963 and the other two entities did not submit a proposal

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding a contract for the sheltering of animals to the Cumberland County SPCA & South Jersey Regional Animal Shelter and appointing them as the animal shelter for the Township of Upper Deerfield pursuant to a Professional Service Contract for the period of March 1, 2018 through December 31, 2018.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to enter into an agreement for the provision of the sheltering of stray animals as per the terms and conditions of the contract rates for March 1, 2018 through December 31, 2018 as provided by the Cumberland County SPCA and South Jersey Regional Animal Shelter and the same is hereby accepted; and

**BE IT FURTHER RESOLVED** that the fees contained within the aforementioned contract are included within the temporary budget and the continuation of any potential additional fees for the year will be included within the adopted 2018 budget to be certified by the Chief Financial Officer upon adoption of the 2018 budget.
