RESOLUTION 18-68

AUTHORIZING EXPENDITURE OF CS REGIONAL MUNICIPAL COURT ALCOHOL EDUCATION AND REHABILITATION FUNDS

WHEREAS, the Cumberland Salem Regional Municipal Court began operations on January 30, 2012, in the Upper Deerfield Township Municipal Building; and

WHEREAS, the court staff are employees and court professionals have contractual agreements with the Township of Upper Deerfield as host community of the shared service regional court and thereby are paid for their services by the Township of Upper Deerfield; and

WHEREAS, the CS Regional Municipal Court has funds available in an Alcohol Education and Rehabilitation account to pay for a special session of the court to hold trials for backlogged DWI cases; and

WHEREAS, the CS Regional Municipal Court has scheduled an eight hour special court session to handle 8 Public Defender backlogged DWI cases on Thursday March 8, 2018; and

WHEREAS, the following court personnel will be needed to hold the special court session with anticipated salary fees that will be in excess of their annual salary identified in Resolution 18-4 in the amount of: \$600 for Lauren Van Embden, Judge; \$300 for Thomas Corrigan, Prosecutor; \$250 for Steven Kernan, Public Defender; \$13.50 per hour for Cindy Kelly, court recorder; and \$25.00 per hour for Randy Ward, court security.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that authorizes funds available from the Alcohol Education and Rehabilitation account for a special court session on Thursday March 8, 2018 to pay the salaries that will be in excess of their annual salary identified in Resolution 18-4 in the amount of: \$600 for Lauren Van Embden, Judge; \$300 for Thomas Corrigan, Prosecutor; \$250 for Steven Kernan, Public Defender; \$13.50 per hour for Cindy Kelly, court recorder; and \$25.00 per hour for Randy Ward, court security; and

BE IT FURTHER RESOLVED that a copy of the Resolution be provided to the CFO.
