RESOLUTION 18-82

AUTHORIZING AWARDING OF CONTRACT FOR SPRING ACTIVATION AND FALL WINTERIZATION TO CERTAIN UNDERGROUND IRRIGATION SYSTEMS WITHIN THE TOWNSHIP OF UPPER DEERFIELD

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing spring activation and fall winterization to irrigation systems within the Township beginning April 1, 2018 to December 31, 2018 from Dutch Neck Landscaping, Rainbow Sprinklers, TBI Unlimited, and Wetlawn Automatic Sprinkler Systems; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal from TBI Unlimited for providing Spring Activation and Fall Winterization to certain underground irrigation systems within the Township, is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning April 1, 2018 to December 31, 2018 as noted above for the Township of Upper Deerfield; and
