

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 19-139**

**AWARDING BID TO CROWN PIPELINE CONSTRUCTION COMPANY FOR THE CONSTRUCTION OF A LOVE LANE WATER MAIN RAILROAD CROSSING**

**WHEREAS**, the Township of Upper Deerfield authorized bids with respect to the construction of a Love Lane Water Main Railroad Crossing; and

**WHEREAS**, bids were received on July 16, 2019 from South State Inc.- \$219,000.00, Pioneer Pipe Company- \$150,700.00 and from Crown Pipeline Construction Company- \$114,570.00; and

**WHEREAS**, Crown Pipeline Construction Company. of Franklinville, New Jersey, submitted the lowest total bid in the amount of \$114,570.00 as set forth in the bid specifications; and

**WHEREAS**, the Engineer has recommended that the bid be awarded to Ricky Slade Construction, Inc. in the amount of \$114,570.00 as the lowest responsible bidder; and

**WHEREAS**, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for the bid to Crown Pipeline Construction Company as aforesaid; and

**WHEREAS**, the award of the aforesaid bid to Crown Pipeline Construction Company is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

**WHEREAS**, funds are available for the base bid contract and have been certified by the local finance officer; and

**NOW THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the bid of Crown Pipeline Construction Company be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract for the construction of a Love Lane Water Main Railroad Crossing in the amount of \$114,570.00 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

**BE IT FURTHER RESOLVED** that bid bonds may be returned to unsuccessful bidders; and

**BE IT FURTHER RESOLVED** that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and be available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
