

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 19-66

AMENDING CFO POSITION AND CERTIFYING SALARY

WHEREAS, the Township of Upper Deerfield and the Pittsgrove Township have entered into a shared service agreement whereby the Township of Upper Deerfield will be providing chief financial officer services to Pittsgrove Township; and

WHEREAS, in the event the shared service agreement between the Township of Upper Deerfield and Pittsgrove Township is cancelled by either party, the CFO salary under this resolution will be terminated from the designated individual and the salary associated with the position listed will be pro-rated to the last day the shared service agreement is in effect.

NOW THEREFORE BE IT RESOLVED, that Amy Colaneri duties are hereby amended to include serving Upper Deerfield Township during 2019 for the purpose of providing chief financial officer services required for the shared service agreement with the Pittsgrove Township for a term beginning on March 1, 2019 and terminating on December 31, 2019; and

BE IT FURTHER RESOLVED, that in the event the shared service agreement between the Township of Upper Deerfield and Pittsgrove Township is cancelled by either party, the officials hired under this resolution will be terminated from the designated position and the salary associated with the positions listed will be pro-rated to the last day the shared service agreement is in effect; and

BE IT FURTHER RESOLVED THAT, Ordinance No. 749, 757, 758, 767B & 802 sets a salary range for various officials of the Township and certain municipal job positions of such term as is fixed by law and the Township Committee wishes to certify for payroll purposes the specific salary amount within the ranges specified for the persons holding said job positions as set forth herein are hereby certified as the 2019 salary or hourly wage rate. In the event the shared service agreement between the Township of Upper Deerfield and Pittsgrove Township is cancelled by either party, Amy Colaneri’s chief financial officer pro-rated annual salary in the amount of \$20,000 for the Pittsgrove Township Shared Service will be terminated from the designated position of chief financial officer for Pittsgrove Township and the salary associated with that position listed will be pro-rated to the last day the shared service agreement is in effect.
