**AWARDING CONTRACT FOR PROVIDING LIFT STATIONS PUMP OUTS
WITHIN THE TOWNSHIP**

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing the pumping out of lift stations within the Township for a term of one year beginning July 1, 2020 to June 30, 2021 from English Sewage Disposal and C&H Disposal Service Inc.; and

WHEREAS, proposals were received from GE Mechanical, English Sewage Disposal and C&H Disposal as follows:
