

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 20-155

IMPOSING LIEN ON BLOCK 907, LOT 4 – 1109 FIRST AVENUE - STANTON

WHEREAS, the property known as Block 907, Lot 4 on the Tax Map of the Township of Upper Deerfield, 1109 First Avenue, with current owner of record listed as Stacey Stanton, had become overgrown with brush, weeds, dead or dying trees, trash, and other debris; and

WHEREAS, the Township of Upper Deerfield notified the owner with respect to the conditions on the property pursuant to Section 57-3 of the Code of the Township of Upper Deerfield; and

WHEREAS, the owner of said property either refused or neglected to address and abate the conditions on the property; and

WHEREAS, the Township of Upper Deerfield, in accordance with Section 57-5 and 57-6 of the Code of the Township of Upper Deerfield, undertook to abate the conditions on the property and to clean up the property; and

WHEREAS, the Township of Upper Deerfield has incurred costs to clean-up the grounds of Block 907, Lot 4, 1109 First Avenue in the amount of \$115.00 on August 20, 2020; and

WHEREAS, the cost of such services has been certified to the Township Committee of the Township of Upper Deerfield;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the amount of \$115.00 be and the same is hereby certified as a lien against Block 907, Lot 4; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a certified copy of this resolution shall be filed with the collector of taxes and the amount charged hereunder, \$115.00 shall become a lien and shall added to and become part of the taxes next to be assessed and levied upon Block 907, Lot 4 and shall bear interest at the same rate as taxes and may be enforced and collected to the same extent and in the same manner as unpaid taxes.
