APPOINTING TOWNSHIP AUDITOR - NICK L. PETRONI

- 1. That the allegations of the preamble hereto are incorporated herein as if fully set forth.
- 2. That Nick L. Petroni CPA, RMA of the firm of Petroni & Associates of Glassboro, New Jersey, a registered municipal accountant authorized to practice accounting in the State of New Jersey, be appointed Township Auditor for Upper Deerfield Township for the year 2021, to perform professional services ordinarily provided by an auditor, and shall receive compensation in accordance with terms of the contract on file in the Clerk's office.
- 3. That the aforesaid contract is awarded pursuant to the use of the Fair and Open Competitive Bid Process.
- 4. The fees contained within the aforementioned contract are included within the temporary budget and the continuation of any additional fees for the year will be included within the adopted 2021 budget to be certified by the Chief Financial Officer upon adoption of the 2021 budget
- 5. The Business Entity Disclosure Certification shall be placed on file with this Resolution.
- 6. That a copy of the specific items pertaining to the award of this contract shall be published in a Notice of Award in the Daily Journal as required by law within ten (10) days of the Resolution authorizing same; and

BE IT FURTHER RESOLVED that the Mayor and Clerk be and are hereby authorized to enter into a contract with Nick L. Petroni CPA, RMA of the firm of Petroni & Associates in a form satisfactory to the Township Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that this professional service agreement is awarded pursuant to and in compliance with the provisions of Pay to Play legislation, <u>N.J.S.A.</u> 19:44A-20.4, et seq.
