RESOLUTION 21-133

AWARDING CONTRACT FOR PROVIDING LIFT STATIONS PUMP OUTS

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing the pumping out of lift stations within the Township for a term of one year beginning July 1, 2021 to June 30, 2022 from English Sewage Disposal and C&H Disposal Service Inc.; and

WHEREAS, proposals were received from GE Mechanical, English Sewage Disposal and C&H Disposal as follows:

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal for providing lift stations pump out services by C&H Disposal and English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award service for a term of one year beginning July 1, 2021 to June 30, 2022 as noted above for the Township of Upper Deerfield; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposals for providing lift stations pump outs by C&H Disposal and English Sewage Disposal is hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award C&H Disposal and English Sewage Disposal for a term of one year beginning July 1, 2021 to June 30, 2022 as noted above for the Township of Upper Deerfield; and
