

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 21-199**

**AUTHORIZING THE TAX COLLECTOR TO ADJUST TAXES FOR A  
WARTIME SERVICE-CONNECTED 100% DISABILITY- LONG**

**WHEREAS**, Long, Randall Earl, property owner of 56 Eisenhower Drive, Block 819 Lot 2, has been certified by the U.S. Department of Veterans Affairs as having a wartime service-connected 100% disability; and

**WHEREAS**, due to his disability, has been approved for a total tax exemption under N.J.S.A. 54:4-3.30, L 1948, C259 which changes his property assessment classification from a 2 to a 15F exempt status and the collection of property taxes; and

**WHEREAS**, the approved disability began on July 12, 2021; and

**WHEREAS**, the property taxes for the 2<sup>nd</sup> quarter 2021 in the prorated amount of \$ 21.60, and the 3<sup>rd</sup> quarter 2021 in the amount of \$ 408.71, need to be refunded for a total amount \$430.31 and the following tax payments for the 4<sup>th</sup> quarter 2021 in the amount of \$ 2,331.03, the 1<sup>st</sup> quarter 2022 in the amount of \$ 1,511.15 and the 2<sup>nd</sup> quarter 2022 in the amount of \$ 1,511.13 need to be waived.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Committee of Upper Deerfield Township, County of Cumberland and State of New Jersey on this 16<sup>th</sup> day of December 2021, determines that the assessed value of the property should be exempted in the amount of \$ 207,800.00 and the property be reclassified as 15F exempt with an effective date of July 12, 2021; and

**BE IT FURTHER RESOLVED** that the Tax Collector is authorized to refund the property taxes for the 2<sup>nd</sup> and 3<sup>rd</sup> 2021 quarters in the amount of \$430.31 and waive the property taxes for the 4<sup>th</sup> quarter in 2021 and the 1<sup>st</sup> and 2<sup>nd</sup> quarters in 2022 and remove any property taxes for the 3<sup>rd</sup> and 4<sup>th</sup> quarter of 2022 when the tax rate is struck, due to the 100% disability exemption.
