RESOLUTION 21-85

AWARDING ENGINEERING SERVICES TO FRALINGER ENGINEERING PA TO PREPARE ENGINEERING FIELD SURVEY, DESIGN, CONSTRUCTION INSPECTION, AND CONTRACT ADMINISTRATION FOR THE RECONSTRUCTION OF LOVE LANE (Railroad to 77), MAPLE AVENUE AND MIDWAY AVENUE

WHEREAS, the Township of Upper Deerfield requested proposals with to Prepare Engineering Field Survey, Design, Construction Inspection, and Contract Administration for the Reconstruction of Roberts Avenue, Charles Avenue, Pleasant Drive, Merlin Drive And Woodmont Circle; and

WHEREAS, proposals were received on December 27, 2019 from Fralinger Engineering. in the amount of \$42,500 for Field Survey & Engineering Design; \$20,000 for Construction Inspection & Administration and \$0.00 to prepare & submit two separate 2022 Grant Applications for State Aid for a total price of \$62,500; and

WHEREAS, Fralinger Engineering of Bridgeton, New Jersey, submitted the lowest proposal in the amount of \$62,500 as set forth in the specifications; and

WHEREAS, the Township Engineer has recommended that the bid be awarded to Fralinger Engineering in the amount of \$62,500 as the lowest responsible proposal; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for the services to Fralinger Engineering as aforesaid; and

WHEREAS, the award of the aforesaid bid to Fralinger Engineering is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

WHEREAS, funds are available for the base bid contract and have been certified by the local finance officer; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal of Fralinger Engineering be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract to Prepare Engineering Field Survey, Design, Construction Inspection, and Contract Administration for the Reconstruction of Love Lane (Railroad to Highway 77), Maple Avenue and Midway Avenue in the amount of \$62,500 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
