RESOLUTION 21-91

AWARDING BID TO COMMAND COMPANY, INC. TO INSTALL PHASE II OF ADA WALKWAYS AT THE MUNICIPAL RECREATION COMPLEX THROUGH A NEW JERSEY DCA SMALL CITIES FACILITIES GRANT

WHEREAS, the Township of Upper Deerfield authorized bids with respect to Install Phase II of ADA Walkways at the Municipal Recreation Complex through a New Jersey DCA Small Cities Facilities Grant; and

WHEREAS, bids were received on April 14, 2021 from Command Company, Inc. - \$229,691.50 and from Ricky Slade Construction, Inc. - \$243,767.00; and

WHEREAS, Command Company, Inc. of Egg Harbor City, New Jersey, submitted the lowest total bid in the amount of \$229,691.50 as set forth in the bid specifications; and

WHEREAS, the Township Engineer has recommended that the bid be awarded to Command Company, Inc. in the amount of \$229,691.50 as the lowest responsible bidder; and

WHEREAS, the Township Committee of the Township of Upper Deerfield is desirous of awarding the contract for the bid to Command Company, Inc. as aforesaid; and

WHEREAS, the award of the aforesaid bid to Command Company, Inc. is in accordance with the provisions of Pay to Play, N.J.S.A. 19:44A-20.4, et seq. in that the bids were publicly advertised and awarded; and

WHEREAS, funds are available for the base bid contract and have been certified by the local finance officer; and

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the bid of Command Company, Inc. be and is hereby accepted and that the Mayor and Clerk be and are hereby authorized to enter into a contract Install Phase II of ADA Walkways at the Municipal Recreation Complex through a New Jersey DCA Small Cities Facilities Grant in the amount of \$229,691.50 pursuant to a contract in a form satisfactory to the Solicitor of the Township of Upper Deerfield; and

BE IT FURTHER RESOLVED that bid bonds may be returned to unsuccessful bidders; and

BE IT FURTHER RESOLVED by the Township Committee of the Township of Upper Deerfield that a copy of this Resolution shall remain on file with the Clerk of the Township of Upper Deerfield and available for public inspection and notice of the award of bid printed in the official newspaper of the Township of Upper Deerfield.
