**AUTHORIZING AWARDING CONTRACT FOR TOWNSHIP EMPLOYEE

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing physicals to Township employees and volunteers for a term of one year beginning July 1, 2022 to June 30, 2023 from RSP Medical LLC, Inspira Medical Center Inc., Internal Medicine Assoc, and Family Practice Associates; and

**WHEREAS**, proposals were received from Inspira Medical Group as follows:
