

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 22-136**

**AUTHORIZING THE TAX COLLECTOR TO ADJUST TAXES FOR A  
WARTIME SERVICE-CONNECTED 100% DISABILITY-**

**WHEREAS**, Smith, Allen D., property owner of 4 Marino Drive, Block 2602 Lot 38, has been certified by the U.S. Department of Veterans Affairs as having a wartime service-connected 100% disability; and

**WHEREAS**, due to his disability, has been approved for a total tax exemption under N.J.S.A. 54:4-3.30, L 1948, C259 which changes his property assessment classification from a 2 to a 15F exempt status and the collection of property taxes; and

**WHEREAS**, the approved disability began on May 16, 2022; and

**WHEREAS**, the property taxes for the 2nd quarter 2022 in the amount of \$ 972.90 to be refunded, and the 3<sup>rd</sup> and 4<sup>th</sup> quarter taxes in 2022 in the amount \$ 4,744.28 to be waived and the taxes for the 1<sup>st</sup> and 2<sup>nd</sup> quarters 2023 in the amount of \$4,754.29 will be waived.

**NOW, THEREFORE, BE IT RESOLVED**, that the Township Committee of Upper Deerfield Township, County of Cumberland and State of New Jersey on this 4<sup>th</sup> day of August 2022, determines that the assessed value of the property should be exempted in the amount of \$180,100.00 for the balance of 2022, and the property be reclassified as 15F exempt with an effective date of May 16, 2022; and

**BE IT FURTHER RESOLVED** that the Tax Collector is authorized to refund the prorated taxes for the 2nd quarter from May 16, 2022, in the amount of \$ 972.90, waive the property taxes for the 3<sup>rd</sup> and 4<sup>th</sup> quarter of 2022 in the amount of \$4,744.28 and waive the 1st and 2nd quarters 2023 in the amount of \$4,754.29, due to the 100% disability exemption.
