**BE IT FURTHER RESOLVED**, that Wayne Shelton is hereby appointed as a Plumbing Inspector to fill in when the Plumbing Sub Code Official is unable to conduct an inspection, effective January 1, 2023, with said term to expire December 31, 2023; Compensation will be paid in accordance with the most current Upper Deerfield Township resolution certifying salaries and that the Plumbing Inspector shall work under the direction and in cooperation with the Township Construction Official and Plumbing Sub Code Official; and

**BE IT FURTHER RESOLVED**, that John Palumbo is hereby appointed as a Building Inspector to fill in when the Building Sub Code Official is unable to conduct an inspection, effective January 1, 2023, with said term to expire December 31, 2023; Compensation will be paid in accordance with the most current Upper Deerfield Township resolution certifying salaries and that the Building Inspector shall work under the direction and in cooperation with the Township Construction Official and Building Sub Code Official; and

**BE IT FURTHER RESOLVED**, that Richard Saunders is hereby appointed as a Fire Inspector to fill in when the Fire Sub Code Official is unable to conduct an inspection, effective January 1, 2023, with said term to expire December 31, 2023; Compensation will be paid in accordance with the most current Upper Deerfield Township resolution certifying salaries and that the Fire Inspector shall work under the direction and in cooperation with the Township Construction Official and Fire Sub Code Official.
