

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 23-105**

**APPROVING RESOURCE EXTRACTION LICENSE FOR K & E HOLDINGS I, LLC ON BLOCK 707, LOTS 2 AND 5**

**WHEREAS**, K&E Holding I, LLC owns Block 707, Lots 2 and 5 on the Tax Maps of Upper Deerfield and utilizes the lands for resource extraction; and

**WHEREAS**, K&E Holding I, LLC resource extraction expansion application was reviewed and approved for operation via Upper Deerfield Township Planning Board Resolutions 4-2016, 1-2017, and 9-2017 for the property that had been licensed as a resource extraction operation since 1989; and

**WHEREAS**, per Upper Deerfield Township Codification Chapter 405-42, K&E Holding I, LLC received approval of a 3-year periodic review of existing operations by the Upper Deerfield Planning Board on March 13, 2023, which approval was memorialized by Upper Deerfield Township Planning Board Resolution 4-2023; and

**WHEREAS**, Upper Deerfield Township Codification Chapter 312 requires a resource extraction operation to receive a license valid for three years from the Township Committee after receiving notification from the Upper Deerfield Township Planning Board that all conditions of the Planning Board approval have been met; and

**WHEREAS**, the Upper Deerfield Township Planning Board has approved the operation of K&E Holding I, LLC via Resolution 4-2023 and all of the terms and conditions of Chapter 312 of the township Ordinances have been met.

**NOW THEREFORE BE IT RESOLVED** that K&E Holding I, LLC, owners of Block 707, Lots 2 and 5 on the Tax Maps of Upper Deerfield, be issued a license for resource extraction by the Upper Deerfield Township Committee for a period of three years commencing on January 1, 2023 and extending to December 31, 2025 as K&E Holding I, LLC has received approval of a 3-year periodic review of existing operations by the Upper Deerfield Planning Board on March 13, 2023; and

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Upper Deerfield that the Mayor and Clerk be and are hereby authorized to execute a license with K&E Holding I, LLC in form satisfactory to the Solicitor of the Township of Upper Deerfield.
