**RESOLUTION 23-133**

**AWARDING CONTRACT FOR PROVIDING REPAIRS OF CONTROL AND ALARM SYSTEMS AT THE TOWNSHIP’S LIFT STATIONS**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing Repair of Control and Alarm System at the Lift Stations for a term of one year beginning August 1, 2023 to June 30, 2024 from GE Mechanical, Complete Control Services, Deltronics Corp, English Sewerage, Municipal Maintenance; and

**WHEREAS**, proposals were received from GE Mechanical, Complete Control System, and English Sewage Disposal as follows:
