**RESOLUTION 23-191**

**AWARDING BID FOR HOME REHABILITATION CONTRACT 2022-6**

**WHEREAS**, the Township of Upper Deerfield authorized the receipt of bid for replacement of a septic system within the Township of Upper Deerfield under the New Jersey Department of Community Affairs projects through Small Cities Grant; and

**WHEREAS**, bids were received on December 6, 2023, from C & H Disposal Service, Inc. in the amount of \$22,990, Pierce Septic Systems, Inc. in the amount of \$23,850 and Septic Systems by Regalbuto Builders in the amount of \$20,900 with regard to the property in compliance with specifications; and

**WHEREAS**, the contractor are deemed to be the lowest responsible bidders with respect to the individuals properties in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

**WHEREAS**, the Township of Upper Deerfield is desirous of accepting the aforesaid bids;

**WHEREAS**, funds are available and have been certified by the local finance officer; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Upper Deerfield that the bids for the septic replacement listed below within the Township of Upper Deerfield are accepted by the Township of Upper Deerfield and are hereby awarded to Septic Systems by Regalbuto Builders with funding through the 2022 Small Cities Home Rehabilitation Grant and 2023 Home Rehabilitation Grant as follows:

Contract 2022-6: 7 Martin Drive – Block 816, Lot 5 - Sheppard– \$20,900.00
