

TOWNSHIP OF UPPER DEERFIELD

RESOLUTION 23-209

AWARDING CONTRACT TO NEW JERSEY EMERGENCY VEHICLES (NJEV), A PL CUSTOM COMPANY TO PURCHASE A 2023 FORD F-550 AMBULANCE

WHEREAS, the Upper Deerfield Emergency Medical Services (“Department”) recommends that Upper Deerfield Township procure an 2023 Type I Classic Ford F-550 4x4 diesel ambulance; and

WHEREAS, the Department has researched vendors that would achieve the Department’s goals and determined that the sought-after equipment may be procured through a nationally recognized and accepted cooperative purchasing contract between Sourcewell (NJPA) and Foley Incorporated.; and

WHEREAS, pursuant to *N.J.S.A. 52:34-6.2b. (3)* (as amended by *P.L. 2011, c.139*) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

WHEREAS, Sourcewell is a regional organization of governments operating under the laws of the State of Minnesota and is a political subdivision of the State of Minnesota; and

WHEREAS, the subject cooperative purchasing contract was awarded by Sourcewell to New Jersey Emergency Vehicles utilizing a competitive contracting process; and

WHEREAS, also pursuant to *N.J.S.A. 52:34-6.2b.(3)* (as amended by *P.L. 2011, c.139*) and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery, have been considered; and

WHEREAS, the Department has determined that Upper Deerfield’s use of the Sourcewell cooperative purchasing contract to procure the sought-after 2023 Type I Classic Ford F-550 4x4 Diesel Ambulance will result in cost savings to Upper Deerfield; and

WHEREAS, consistent with the Sourcewell cooperative purchasing contract and needs of Upper Deerfield, New Jersey Emergency Vehicles has submitted a proposal to provide one 2023 Type I Classic Ford F-550 4x4 Diesel Ambulance to Upper Deerfield for the sum not to exceed \$376,111.00 using Sourcewell Account No RFP110921; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Township of Upper Deerfield,

1. The foregoing “WHEREAS” clauses are hereby incorporated as if fully restated.
2. A contract for the purchase of a 2023 Type I Classic Ford F-550 4x4 Diesel Ambulance / New Jersey Emergency Services (NJEV) for the sum not to exceed \$376,111.00 is hereby awarded without public bidding as permitted by law.

3. The Township Clerk is hereby authorized and directed to execute an “End User Agreement” with Foley Incorporated pursuant to the terms of its nationally recognized and accepted cooperative purchasing agreement with Sourcewell.
