

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 24-56**

**APPROVAL OF CHANGE ORDER #1 FOR THE CONTRACT TO  
TKT CONSTRUCTION INC. TO CONSTRUCT THE REPLACEMENT OF THE  
SEABROOK WATER TOWER – PROJECT NO. 0613004-002 THROUGH FUNDING  
PROVIDED BY THE NEW JERSEY WATER BANK**

**WHEREAS**, a contract was awarded by Resolution 23-156, in the amount of \$3,183,360.00 to TKT Construction Inc. to Construct the Replacement of the Seabrook Water Tower – Project No. 0613004-002 Through Funding Provided by the New Jersey Water Bank; and

**WHEREAS**, the following change orders were required to complete construction

1. Reduce the elevation of the Water Tower by 5 feet to be more consistent with the Love Lane Warer Tower in the amount of \$14,364.45; and
2. To perform additional test pits to determine precise location of old fire lines in the amount of \$3,641.35; and

**WHEREAS**, the total cost of the change orders is \$18,005.80; and

**WHEREAS**, the contractor and Township Engineer have agreed to the change orders; and

**WHEREAS**, the Township Engineer has recommended such work for this project; and

**WHEREAS**, the local finance officer has certified that funds are available.

**NOW, THEREFORE, BE IT RESOLVED** that a change order in the amount of an increase of \$18,005.80 to do the aforementioned work be added to the contract between TKT Construction Inc. and the Township of Upper Deerfield, to provide for the work, is hereby approved; and

**BE IT FURTHER RESOLVED** that the final contract amount for TKT Construction Inc. is hereby increased to \$3,201,365.80; and

**BE IT FURTHER RESOLVED** that a copy of the resolution be given to the Treasurer and finance office.
