### **RESOLUTION 24-58**

# AWARDING CONTRACT TO MODERN POWER SYSTEMS TO PURCHASE GENERAC INDUSTRIAL GENERATOR

**WHEREAS,** Upper Deerfield Township Public Works ("Department") recommends that Upper Deerfield Township procure a Generac Industrial gaseous engine-driven generator; and

WHEREAS, the Department has researched vendors that would achieve the Department's goals and determined that the sought-after equipment may be procured through a nationally recognized and accepted cooperative purchasing contract between Sourcewell (NJPA) and Modern Power Systems.; and

WHEREAS, pursuant to *N.J.S.A.* 52:34-6.2b. (3) (as amended by *P.L.* 2011, c.139) and LFN 2012-10, a New Jersey municipality may purchase goods and services without public bidding under the Local Public Contracts Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within New Jersey or another state; and

**WHEREAS,** Sourcewell is a regional organization of governments operating under the laws of the State of Minnesota and is a political subdivision of the State of Minnesota; and

**WHEREAS,** the subject cooperative purchasing contract was awarded by Sourcewell to Modern Power Systems utilizing a competitive contracting process; and

**WHEREAS,** also pursuant to *N.J.S.A.* 52:34-6.2b.(3) (as amended by *P.L.* 2011, *c.139*) and LFN 2012-10, prior to making purchases under nationally-recognized and accepted cooperative purchasing contracts, the municipality must determine that the use of the cooperative purchasing contract shall result in cost savings after all factors, including charges for service, material, and delivery, have been considered; and

WHEREAS, the Department has determined that Upper Deerfield's use of the Sourcewell cooperative purchasing contract to procure the sought-after Generac Industrial gaseous engine-driven generator will result in cost savings to Upper Deerfield; and

WHEREAS, consistent with the Sourcewell cooperative purchasing contract and needs of Upper Deerfield, Modern Power Systems has submitted a proposal to provide one Generac Industrial gaseous enginedriven generator to Upper Deerfield for the sum not to exceed \$26,050.00 using Sourcewell Account No 092222-GNR; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available for this purchase.

# NOW, THEREFORE, BE IT RESOLVED by the Township of Upper Deerfield,

- 1. The foregoing "WHEREAS" clauses are hereby incorporated as if fully restated.
- 2. A contract for the purchase of a Generac Industrial gaseous engine-driven generator Modern Power Systems for a sum not to exceed \$26,050.00 is hereby awarded without public bidding as permitted by law.

3. The Township Clerk is hereby authorized and directed to execute an "End User Agreement" with Foley Incorporated pursuant to the terms of its nationally recognized and accepted cooperative purchasing agreement with Sourcewell.
