AMENDING PROFESSIONAL SERVICE CONTRACT TO MARK BLAUER - DBA/BLAUER ASSOCIATES

- 3. This contract is awarded without competitive bidding as a professional service in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law, because said services are exempt pursuant to the provisions of the law.
- 4. A copy of the agreement has been filed with the Township Clerk and is available for public inspection in the office of the Township Clerk during normal business hours.
- 5. Funds are available and have been certified by the local finance officer.
- 6. The Business Entity Disclosure Certification shall be placed on file.
- 7. That a copy of the specific items pertaining to the award of this contract shall be published in a Notice of Award in the Daily Journal

BE IT FURTHER RESOLVED that the award of this agreement for professional services is consistent with and in accordance with the provisions of N.J.S.A. 40A:11-1 et seq and N.J.S.A. 19:44-20.5.
