RESOLUTION 24-93

**APPROVAL OF CHANGE ORDER #2 FOR THE CONTRACT TO
TKT CONSTRUCTION INC. TO CONSTRUCT THE REPLACEMENT OF THE SEABROOK
WATER TOWER – PROJECT NO. 0613004-002 THROUGH FUNDING PROVIDED BY THE
NEW JERSEY WATER BANK**

WHEREAS, a contract was awarded by Resolution 23-156, in the amount of \$3,183,360.00 to TKT Construction Inc. to Construct the Replacement of the Seabrook Water Tower – Project No. 0613004-002 Through Funding Provided by the New Jersey Water Bank; and

WHEREAS, the original contract was amended by Resolution 24-56 with change orders totaling \$18,005.80 bringing the total project cost to \$3,201,365.80

WHEREAS, the following change orders are required to complete construction

1. Furnish and install insertion valve on 10” water main in the amount of \$24,598.18; and
2. Furnish and install fire hydrant, pipe and thrust block in the amount of \$15,091.98; and
3. Close Foster Road from the bend on N. Parsonage Road to Parsonage Road in the amount of \$15,382.11.

WHEREAS, the total cost of the three change orders is \$55,072.27; and

WHEREAS, the contractor and Township Engineer have agreed to the change orders; and

WHEREAS, the Township Engineer has recommended such work for this project; and

WHEREAS, the local finance officer has certified that funds are available.

NOW, THEREFORE, BE IT RESOLVED that a change order in the amount of an increase of \$55,072.27 to do the aforementioned work be added to the contract between TKT Construction Inc. and the Township of Upper Deerfield, to provide for the work, is hereby approved; and

BE IT FURTHER RESOLVED that the final contract amount for TKT Construction Inc. is hereby increased to \$3,256,438.07; and

BE IT FURTHER RESOLVED that a copy of the resolution be given to the Treasurer and finance office.
