RESOLUTION 24-150

**AWARDING CONTRACT FOR PROVIDING JETTING
& VACCING PIPES WITHIN THE TOWNSHIP**

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing Jetting and/or Vaccing Sewer Pipes and/or Storm Drainage Pipes within the Township for a term of one year beginning August 1, 2024 to June 30, 2025 from English Sewage Disposal, GE Mechanical Inc, Video Pipe Services; and

WHEREAS, proposals were received from English Sewage Disposal and GE Mechanical as follows:

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Upper Deerfield that the proposal for Jetting and/or Vaccing Sewer Pipes and/or Storm Drainage Pipes by English Sewage Disposal are hereby accepted, and that the Mayor and Clerk be and are hereby authorized to award routine and emergency service for a term of one year beginning August 1, 2024 to June 30, 2025 as noted above for the Township of Upper Deerfield; and
