**RESOLUTION 24-151**

**AWARDING CONTRACT FOR PROVIDING LIFT STATIONS PUMP OUTS**

**WHEREAS**, the Township of Upper Deerfield requested proposals with respect to providing the Pumping Out of Lift Stations within the Township for a term of one year beginning August 1, 2024 to June 30, 2025 from English Sewage Disposal, GE Mechanical and C&H Disposal Service Inc.; and

**WHEREAS**, proposals were received from GE Mechanical, C&H Disposal Service Inc. and English Sewage Disposal as follows:
