RESOLUTION 24-152

AWARDING CONTRACT FOR PROVIDING REPAIRS OF CONTROL AND ALARM SYSTEMS AT THE TOWNSHIP’S LIFT STATIONS

WHEREAS, the Township of Upper Deerfield requested proposals with respect to providing Repair of Control and Alarm System at the Lift Stations for a term of one year beginning August 1, 2024 to June 30, 2025 from GE Mechanical, Complete Control Services, Deltronics Corp, English Sewerage, Municipal Maintenance; and

WHEREAS, proposals were received from GE Mechanical, Complete Control System, and English Sewage Disposal as follows:
