

**TOWNSHIP OF UPPER DEERFIELD**

**RESOLUTION 24-197**

**APPROVAL OF CHANGE ORDER #3 FOR THE CONTRACT TO  
TKT CONSTRUCTION INC. TO CONSTRUCT THE REPLACEMENT OF THE SEABROOK  
WATER TOWER – PROJECT NO. 0613004-002 THROUGH FUNDING PROVIDED BY THE  
NEW JERSEY WATER BANK**

**WHEREAS**, a contract was awarded by Resolution 23-156, in the amount of \$3,183,360.00 to TKT Construction Inc. to Construct the Replacement of the Seabrook Water Tower – Project No. 0613004-002 Through Funding Provided by the New Jersey Water Bank; and

**WHEREAS**, the original contract was amended by Resolution 24-56 with change orders totaling \$18,005.80 and Resolution 24-93 with change orders totaling \$55,072.27 bringing the total project cost to \$3,256,438.07

**WHEREAS**, the following change orders are required to complete construction

1. Furnish and install wireless water level sensor and transmitter on the water tank to furnish and install receiver and pump controls in the Seabrook Water Plant in the amount of \$47,427.88; and

**WHEREAS**, the total cost of the three change orders is \$47,427.88; and

**WHEREAS**, the contractor and Township Engineer have agreed to the change orders; and

**WHEREAS**, the Township Engineer has recommended such work for this project; and

**WHEREAS**, the local finance officer has certified that funds are available.

**NOW, THEREFORE, BE IT RESOLVED** that a change order in the amount of an increase of \$47,427.88 to do the aforementioned work be added to the contract between TKT Construction Inc. and the Township of Upper Deerfield, to provide for the work, is hereby approved; and

**BE IT FURTHER RESOLVED** that the final contract amount for TKT Construction Inc. is hereby increased to \$3,303,865.95; and

**BE IT FURTHER RESOLVED** that a copy of the resolution be given to the Treasurer and finance office.
