## ORDINANCE 873

### AN ORDINANCE FIXING SALARIES OF CERTAIN OFFICIALS OF THE TOWNSHIP OF UPPER DEERFIELD IN THE COUNTY OF CUMBERLAND, PROVIDING THE TERMS OF PAYMENT THEREOF AND REPEALING ORDINANCES INCONSISTENT THEREWITH,

**BE IT ORDAINED** by the Township Committee of the Township of Upper Deerfield, in the County of Cumberland; that:

**Section 5.** Ordinances No. 836 and all other ordinances and parts of ordinances inconsistent herewith are hereby repealed.

**Section 6.** This ordinance shall take effect for all persons employed by the township as of January 1, 2025, and be subject to publication as required by law, and shall be in effect until further action of the Township Committee.
